An 11" ponderosa pine bears N 07° E-39.9 feet, scribed: 1/4 S32 SC BT.

A 6" ponderosa pine bears N 32° E-54.7 feet, scribed: 1/4 S32 SC BT.

Bearing trees have a brass washer stamped 'PLS 1106' nailed to the face of the blaze. Attached bearing object and witness signs to each tree; painted a 6" band and face of blaze red.
