HISTORY OF ORIGINAL CORNER ESTABLISHED:

Corner originally established under GLO Special Instructions dated May 4, 1887 executed by N. Currin and E. Noland. Surveyor General record states:


Set post 3 ft long, 3 ins square 24 ins in the ground for 1/4 sec cor marked 1/4 S on N face from which: A fir 14 ins. diam. bears N 70° E 17 lks dist marked 1/4 S BT. A fir 16 ins. diam. bears S 45° E 28 lks dist marked 1/4 S BT.

Corner was remonumented from original accessories by L. E. Wilkes in Dependent Resurvey completed under GLO Contract No. 29, dated May 3, 1917. Surveyor General record states:

Intersect the point for 1/4 sec. cor., located by reference to the bearing trees. At the exact cor. point Set an iron post, 3 ft. long, 2 ins. diam., 24 ins. in the ground, for 1/4 sec. cor., with brass cap marked as shown. From which: A fir, 18 ins. diam., bears S 45° E, 28 lks. dist.,

blazes healed over, not opened (Old B.T.) A fir, 24 ins. diam., bears N 70° E, 36 lks. dist., blazes healed over, not opened (Old B.T.)

DESCRIPTION OF CORNER EVIDENCE FOUND:

Found a 1 3/4" iron pipe with a 2 ½" brass cap marked as shown below, 8" above ground.

Found a 15" stump bears North 70° East, a distance of 23.5 feet, with healed blaze evident.

Found a 15 inch dead and downed tree, the stump hole which bears South 45° East, a distance of 19 feet.

DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

From the Iron Pipe monument,

NEW BEARING OBJECTS:

A 16 inch Douglas Fir bears North 20° East, a distance of 50.70 feet, marked 1/4 S7 BT. A 17 inch Douglas Fir bears North 79° West, a distance of 62.50 feet, marked X BT. A 15 inch Douglas Fir bears South 5° West, a distance of 37.00 feet, marked 1/4 S18 BT A 16 inch Douglas Fir bears North 5° West, a distance of 37.70 feet, marked 1/4 S7 BT.


Set a steel fencepost approximately 1 foot East of corner monument.
