CORNER DESIGNATION: 49.5, 49 1/2 mile monument on Umatilla Indian Reservation in Section 34, TlN., R35E., W.M.

PREVIOUS RENEWALS/SURVEYS, ETC.: Corner established by James P. Currin and James Noland, under Special Contract, dated May 4, 1887. Notes state: Set basalt stone, 16 X 16 X 10 ins. 9 ins. in the ground for 1/2 mile stone marked 1/2 M. on S. and U.R. on W. faces, from which:

A pine 16 ins. in diam. bears S 60° W., 18 lks. A pine 8 ins. in diam. bears S 80° E 12 lks. Each marked 1/2 M U R B T.

MONUMENT AND ACCESSORIES FOUND: No evidence of corner stone was found. Found evidence of both original bearing trees as follows:

A live 24" ponderosa pine bears S 84° E 7.9' to face of blaze, with scribes "1/2 M" visible after opening blaze.

A 28" sawn ponderosa pine stump bears S  $64^\circ$  W 11.9' to face of blaze with scribes "R BT" visible after opening stump.

Re-established corner point by measuring record distance from the face of blaze of the recovered original bearing trees.

There is a fence line approximately 10 feet East of re-established corner point.

## MONUMENT MARKING DETAIL:

## MONUMENT SET:

At re-established corner point, set a 2 1/2" aluminum cap on 2 1/2" by 30" aluminum pipe, 22" in the ground and surrounded with a mound of earth and stone. Cap marked as shown in corner diagram.

New Accessories:

A 10" ponderosa pine bears N 48° E 36.5' scribed UIR 49 1/2 M BT. A 9" ponderosa pine bears S 58° E 21.2' scribed UIR 49 1/2 M BT. A 9" ponderosa pine bears N 18° W 19.3' scribed UIR 49 1/2 M BT.

Attached witness sign to steel fence post 3' North of corner. Attached bearing object signs to the bearing trees.

LOCATION & COMMENTS: Corner located on ridgetop about 10 ft. West of a fenceline approximating the old Reservation Boundary.

COMPASS DECLINATION: 18° East.
