Description of corner evidence found:

At the corner point, we find a 3/4" iron pipe extending 24" above ground in a mound of stone approx. 2 ft. dia. and 1 ft. high,

From which: The remains of the original bearing trees: A standing 26" Ponderosa Pine snag with scribing "TIN S22" visible on an open blaze bears N 64°E 33.4 ft. (32.3 ft. to face). It appears that the open blaze is the original, however the scribing appears to be recently made or touched up. We open the lower blaze near ground level and find good scribing "BT"

A sawn Ponderosa Pine stump 24" dia. bears S 24°E 48.3 ft. (47.5 to face) with

unhealed and burnt single blaze, no scribing visible. The tree portion from this stump is lying alongside with scribing "R35E S27" visible on an open blaze.

A sawn Ponderosa Pine stump, 20" dia., bears S 57° W 33.0 ft., the tree portion is gone. We open and find good scribing "BT" on a single blaze near ground level. Bearing trees marked recently: (Continued on Page 2)

Description of monument and accessories I established to perpetuate the original location of this corner:

At the corner point and in place of the found 3/4" iron pipe, we set a 2"x30" galvanized iron pipe, 20" in the ground to bedrock and rebuild mound of stone around 2" iron pipe 3 ft. dia. and 1 ft. high, with brass cap attached, marked: TIN R35E We reset 3/4" iron pipe alongside of brass cap and mark the following new bearing trees:

A 12" Douglas Fir, scribed "T1N R35E S22 BT" on a double blaze PLS 1099 bears N 31°E 44.7 ft. 1983

A 12" Ponderosa Pine, scribed "TIN R35E S28 BT" on a double blaze bears S 83°W 73.7 ft.

A 6" Ponderosa Pine, scribed "T1N R35E S27 BT" on a double blaze bears S25 1/2° E 30.4 ft.

And a 12" Ponderosa Pine, scribed "T1N R35E S21 BT" on a double blaze bears N 59 1/2°W 56.7 ft.

Attached brass washer marked "LS 1099" to lower blaze of new BT's. Bearing and Horizontal Distance measured to center of bearing trees at ground level.

A 16" Douglas Fir, in good condition with scribing "S27 T1N R35 visible on a partially healed single blaze bears S87 1/2°E 4.4 ft. And a 10" standing Lodge Pole Pine snag with scribing "S21 T1N R35 BT" visible on an unhealed single blaze bears N 12°W 14.4 ft.

We are unable to find a location where more than two dimensions given in the original notes can be utilized. Individual points established at record measurement from each original BT are spread over an area approx. 16 ft. N-S and 6 ft. E-W. An average of the position falls approx. 3 ft. from the found 3/4" iron pipe. We decide to accept the position of the 3/4" iron pipe since it is near the average position dictated by the original evidence and it is generally faced by all three original blazes.
