MONUMENT AND ACCESSORIES FOUND: No evidence of corner post or original bearing trees was found. Re-established corner on line between the Northwest corner of Section 34 and the re-established location for the closing corner on the Umatilla Indian Reservation Boundary. Corner point was established on line between above referenced corners at a point 0.50 chains (33 feet) East of the spring branch called for in original notes. Note: There are now two spring branchs, the most westerly branch is the original branch. The east branch was formed by damming of the spring branch. From the re-established corner position, a fence corner bears S 89° W 22 ft., with fences extending South and West.
