Marked T.1N, R.34E., Sec. 36 on N.W., T.1N, R.35E., Sec. 31 on N.E. faces with mound of stone alongside. I reestablish this cor. by setting post, 4 ft. long, 4 ins. square, 24 ins. in the ground, for cor. to T.1N., Rgs. 34 and 35 E. marked S C T 1 N on N., R 35 E

S 31 on E., and R 34 E S 36 on W. faces with 6 notches on N. E. and W. edges, and raised mound of stone 2 1/2 ft. high, 5 1/2 ft. base over it."

Record 95-16-C, 7/11/94: Found mound of stone, mound is reasonably intact on east edge of small drainage at brow of hill into Bell Cow Canyon. Nothing found of post. Jim Hambleton had placed a nail in the mound during an earlier timber survey.
