MONUMENT AND ACCESSORIES FOUND: A firmly set basalt stone 13 in. \times 8 in. \times 7 in. with 3 distinct grooves on 1 face and 2 faint grooves on another face, with a surrounding mound of stone.

MONUMENT SET: At position of found basalt stone set a 2 1/2 in. brass cap on a 1 1/2 in. x 30 in. galvanized iron pipe, projecting 6 in. with a 3 foot diameter mound of stone to cap (marked as shown in the monument detail). Original stone was buried on West side of new monument.

Corner falls on steep West facing hillside in a clearing approximately 200 feet below top of ridge and approximately midway between two East-West running ravines.
