
History of original corner establishment:

Corner originally established by Henry Meldrum under GLO contract number 450, dated June 11, 1882. Surveyor General record states:

Set post 3 ft long 3 ins square 24 in in ground for ½ sec cor marked ½S on N face from which;

A pine 30 in diam bears N27°W 11 lks dist marked \S BT A fir 18 in diam bears S30°E 12 lks dist marked \S BT



No record of subsequent monumentation found in Umatilla County survey records.

Description of corner evidence found:

Found the rotted remains of the original corner post to a depth of 10 inches.

ORIGINAL BEARING TREES Found a 28 inch diameter White Fir S30°E, 12 lks, live with a broken top, with scribes visible.

Found a rotted Ponderosa Pine stump N40°W, 11 lks with no marks visible (Record N27°W)

Distances to the original BTs are to the estimated face of blaze.

Found a small mound of stone with a rotted post (no marks visible) approximately 6 feet West of the true corner. Both mound and stone were too recent to be the original corner monument.

Description of monument and accessories I established to perpetuate the

original location of this corner: In place of the found original corner post, I set a $2\frac{1}{2}$ " x 30" aluminum pipe with aluminum cap marked as shown, 26 inches in the ground, from which:

New BTs: A 20 inch diameter Ponderosa Pine bears N7°E, 68.52 feet marked ¼ S16 BT A 13 inch diameter Ponderosa Pine bears S22°E, 22.08 feet marked ¼ S21 BT

Painted a 6 inch red band around all BTs and attached bearing tree and land survey monument signs.

Set a steel fencepost approximately 5 feet East with land survey monument sign attached.

Raised small mound of stone around monument.
