CORNER DESIGNATION: V-21. Northeast corner Section 35, T2N., R32E., W.M.

PREVIOUS RENEWALS/SURVEYS, ETC.: Most recent approved GLO Survey was made by James P. Currin and James Noland, under Special Contract dated May 4, 1887. They recovered old corner and set a stone 20 x 12 x 8 ins., 14 inches in the ground marked with 1 notch on E. and S. edges; re-dug pits 18 x 18 x 12 ins., in each section 5 1/2 ft. distant from stone and raised a mound of earth 2 ft. high, 4 1/2 ft. base over it. This corner was re-established by PLS 1280 in 1982 in Umatilla County Survey No. 82-51-C.

MONUMENT AND ACCESSORIES FOUND: Found 3" brass cap on galvanized iron pipe set 14" below ground, per Umatilla County Survey No. 82-51-C. This corner monument was rejected because it was established using the Daniel Chaplin rather than Currin and Noland GLO record.

MONUMENT MARKING DETAIL:

MONUMENT SET: Corner postion was re-established by double proportion measurement between the Northwest corner of Section 35, the Southeast corner of Section 25, the Northeast corner of Section 26, and the Southeast corner of Section 35, using the Currin and Noland record. At the re-established corner postion, set a 2 1/2" brass cap on a 1 1/4" x 30" galvanized iron pipe, 42" in the ground, (marked as shown in the monument detail). The rejected monument by PLS 1280 bears S 60°16' E - 5.8 feet.

New Accessories:

A $5/8" \times 30"$ iron pin with yellow plastic cap stamped "OR PLS 1106-WA PLS 17372" bears N 52° E-22.4 feet, top set 1.2 feet below ground.

A $5/8" \times 30"$ iron pin with yellow plastic cap stamped "OR PLS 1106-WA PLS 17372" bears S 40° E-24.7 feet, top set 1.2 feet below ground.

A $5/8" \times 30"$ iron pin with yellow plastic cap stamped "OR PLS 1106-WA PLS 17372" bears S 26" W-19.7 feet, top set 1.2 feet below ground.

A $5/8" \times 30"$ iron pin with yellow plastic cap stamped "OR PLS 1106-WA PLS 17372" bears N 41 1/2° W-12.7 feet, top set 1.3 feet below ground.


