PREVIOUS RENEWALS/SURVEYS, ETC.: Most recent approved GLO survey was made by James P. Currin and James Noland, under Special Contract dated May 4, 1887. They set a stone, 16 X 10 X 6 ins., 10 ins. in the ground for 1/4 Sec. corner. Marked 1/4 on W. face. Dug pits 18 x 18 x 12 ins. N. & S. from stone 5 1/2 ft. distant and raised a mound of earth 1-1/2 ft. high, 3-1/2 ft. base over it. This corner was re-established by PLS 1280 in 1982 per Umatilla County Survey No. 82-51-C.

MONUMENT AND ACCESSORIES FOUND: Found 3" brass cap on galvanized iron pipe set 15" below ground per Umatilla County Survey No. 82-This corner monument was rejected because it and other controlling corners were established using the Daniel Chaplin rather than the Currin and Noland GLO record.

MONUMENT MARKING DETAIL:

T2N R32E 1/4 S35 S36 1994 PLS 1106

MONUMENT SET: Corner position was re-established by single proportion measurement, using the GLO record by Currin and Noland, between re-established or recovered corners at the Northeast and Southeast corners of Section 35. At re-established corner position, set a 2 1/2" brass cap on 1 1/4" x 30" galvanized iron pipe, 42" in ground, (marked as shown in the monument detail). The rejected monument by PLS 1280 bears S 61°24' E - 2.9 feet.

New Accessories:

A 5/8" x 30" iron pin with yellow plastic cap stamped "OR PLS 1106-WA PLS 17372" bears N 40 1/2° E-39.3 feet. A $5/8" \times 30"$ iron pin with yellow plastic cap stamped "OR PLS 1106-WA PLS 17372" bears S 45° E-26.6 feet. Power pole with a brass washer stamped "PLS 1106", nailed to it, bears S 64° W-40.3 feet. A 5/8" x 30" iron pin with yellow plastic cap stamped "OR PLS 1106-WA PLS 17372", bears N 48 1/2° W-47.9 feet. Attached bearing object signs to iron pins and above brass washer. Set steel fence posts near iron pins with witness signs attached.

LOCATION AND COMMENTS: Corner falls in farmed Conservation Reserve Program field.
