A fir, 14 ins. diam., brs. S52°E, 35 lks. dist., marked S31 B.T.


A pine, 16 ins. diam., brs. S42°W, 62 lks. dist., marked R33E S36 B.T.

References to Range 34 East were obliterated and the letters UR added for the Reservation Boundary under the same contract.

Monument and Accessories found: (condition and source)

A 31" dbh Fir, plainly scribed, S31°E, 23.1feet; A 31" dbh pine, plainly scribed, S36°W, 40.92 feet; A 37" pine, no visible scar, N85°W, 59 feet; A 4 foot steel post driven S9°E 2.1 feet from the corne



MONUMENT (S) AND ACCESSORIES SET (Procedures and Description) Set a 1 1/4" x 30" Galvanized Iron Pipe with a 2 1/2" brass cap stamped as shown in the diagram above at the correct distances from the scribed bearing trees. Attached a county monument sign to the existing steel post.

For references, I set three 5/8" by 24" rebars with 1.25" red plastic caps stamped ORLS 852 and WALS 13922 as described below:

an iron rebar bears N30°04'01"W, 31.05 feet;

an iron rebar bears N55°52'22"E, 39.79 feet;

an iron rebar bears N1°24'34"W, 192.44 feet at the position of the closing corner for sections 19; and 30, Range 34 East, as determined from the dead pine bearing tree for that corner.

The monument and references were tied using a LIECA system 300 RTK GPS.
