PREVIOUS RENEWALS/SURVEYS ETC.: Corner originally established by D. S. Payne, under Contract 100, dated August, 1, 1861. Notes state: Set charred stake with mound trench and pits as per instrs. for 1/4 sec. cor. John Kimbrell, in his 1900 survey recorded at Record of Private Surveys, Book 1, Page 424, indicates he recovered the "acknowledged corner" but did not state what he found. Frank Hayes, in his undated Survey No. Q-521-C, states he set a "1" I.P."

MONUMENT AND ACCESSORIES FOUND: The Hayes "1" I.P. was not found. In Survey No. 06-462-C, we recovered a 1" pipe, lying flat, near the position for the South 1/16th. Hayes Survey No. Q-521-C stated he set a "1" I.P." for this 1/16th corner.

MONUMENT MARKING DETAIL:

T2N R31E|R32E 1/4 S13| S18 2013 PLS 54657

MONUMENT SET: Held the intersection of the proportional latitude between the West 1/4 corner of Section 6 and the Southwest corner of Section 18 with a North-South field line as best remaining evidence of the original corner location. At the reestablished corner point, set a 2 3/8" brass cap on a 1 1/4" x 30" galvanized iron pipe with top 20" below ground level, marked as shown in "Monument Marking Detail", from which:

A silver deep-1 magnet, buried 20" in the ground, bears North 42 1/2° East, 38.1 feet. A pink deep-1 magnet, buried 20" in the ground, bears South 46° East, 32.8 feet. A blue deep-1 magnet, buried 20" in the ground, bears South 46° West, 31.8 feet. An orange deep-1 magnet, buried 20" in the ground, bears North 51° West, 30.2 feet. Buried bearing object tags with all magnets.

LOCATION AND COMMENTS: Corner falls in a North-South field line.
