MONUMENT AND ACCESSORIES FOUND:

Accepted the lone railroad tie fence post at the intersection of field lines running East-West and South as the best remaining evidence of the original corner position (this post was moved and reset approximately 2.0' North of new Aluminum Cap. See the 2012 J-U-B Engineers, Inc. Partition Plat for Tim Weidert for complete survey and corner details.

MONUMENT SET:

Set 2-1/4" x 18" Aluminum pipe with a 3-1/4" Aluminum Cap with Deep-1 magnet in concrete, set flush with ground surface. The monument is approximately 2.0' South of the existing lone fence post. The Aluminum Cap is marked as shown above in the Monument Marking Detail.

NEW ACCESSORIES:

Set mag nail with red plastic washer stamped "JUB Control" in 6-0' tall lone railroad tie fence post, 1.0' above ground in South side of said fence post with bearing tag which bears N0°E, 1.62' from Aluminum Cap.

Set a 1/2" x 24" iron rebar with red plastic cap stamped "JUB Control", 24" below ground surface which bears S52°W, 7.56' from Aluminum Cap.
