A 5/8" x 24" iron rod with a 1 1/4" purple plastic cap marked "Wells Surveying, PLS 54657", set 6" below ground in bank on North side of field road between road and farmed field, bears South 89° East, 25.3 feet.

A 5/8" x 24" iron rod with a 1 1/4" purple plastic cap marked "Wells Surveying, PLS 54657", set 6" below ground in bank on North side of field road between road and farmed field, bears South 87° East, 51.1 feet.

A blue deep-1 magnet, 18" below ground, bears South 08° West, 41.5 feet.

A 5/8" x 24" iron rod with a 1 1/4" purple plastic cap marked "Wells Surveying, PLS 54657", set 6" below ground in bank on North side of field road between road and farmed field, bears South 88° West, 18.1 feet.

Wired bearing object signs to rebar and buried bearing object signs with magnets. Attached witness post sign to railroad tie post 8" North of monument.

Monument set 8 inches South of centerline of rail road tie field marker post on North side of farm field road.
