Set porous stone, glass & coal under. In Survey No. 12-126-B, John Shea computed the corner position at the line between the Northeast and Southeast corners of Section 29 at the intersection with the centerline of Snyder Road. No monument was found or set.

MONUMENT SET: Held intersection of the centerline of Snyder Road with a line between the Northeast and Southeast corners of Section 29 as the best remaining evidence of the original corner position, At the reestablished corner position, set a 2 3/8" brass cap on a 1 1/4" x 30" galvanized iron pipe, with top 12" below road surface, stamped as stated in "Monument Marking Detail". From which:

A silver deep-1 magnet, buried 18" below ground in road bank between road and farmed field bears North 62° East, 29.2 feet.

A 5/8" x 24" rebar with a 1 1/4" purple plastic cap stamped "Wells Surveying, PLS 54657", in bank between road and farmed field, South 62 1/2° East, 31.9 feet.

A Umatilla County Road mile marker sign base at ground bears South 68° West, 48.7 feet. An orange deep-1 magnet, buried 18" below ground, bears North 59 1/2° West, 27.0 feet. Buried witness post sign with magnets. Attached bearing object signs to rebar and sign base.
