Corner reestablished by John Kimbrell, 1906, Record of Private Survey Book 1, Page 580, record states: "Set iron bolt 20" long for cor to secs 28, 29, 32 and 33". Corner computed by Stephen Haddock, 10-2006, Survey 06-606-C, record states "corner point calculated using data from survey of record. No monument found or set." Corner computed by John Shea, 08/27/12, Survey No. 12-126-B, record states: "Calculated position. Corner obliterated. Held the calculated position of the Southeast corner of Section 29 as shown in survey reference No. 4 (Survey 89-123-B). Based on ties to found monuments at the Southeast corner and Southwest corner of Section 32. No monument found or set in this survey. The corner point position was located by the City of Pendleton in 1978 in Survey No. 89-123-B.

MONUMENT SET: The corner point was re-established at the position determined on Survey No. 89-123-B by ties to said City survey. Corner point falls 0.20 foot North of 6" diameter green treated fence post. Set a 2 3/8" brass cap on a 1 1/4" x 30" galvanized iron pipe with top flush with ground marked as shown in "Monument Marking Detail" from which:

A silver deep-1 magnet, buried 20" in the ground, bears North 43° East, 28.2 feet.

A purple deep-1 magnet, buried 20" in the ground, bears South 43° East, 36.1 feet.

A blue deep-1 magnet, buried 20" in the ground, bears South 42 ½°West, 42.2 feet.

An orange deep-1 magnet, buried 20" in the ground, bears North 60° West, 44.8 feet.

Attached witness post sign to fence post near monument, buried bearing object signs with magnets.
