

MONUMENT SET:

After reviewing highway right-of-way maps and county road notes, and discussions with Bob English, it was determined that the 1/4 corner should be moved west to better fit the center of the Havana-Helix Highway. it was agreed that his brass cap would become a reference monument. Set a mag nail with brass washer marked "LS2627" at the revised corner location and stamped the brass cap with an arrow pointing to the corner and add the letters "RM" and the distance "25.24" 25.24

NEW ACCESSORIES:

English's brass cap becomes an accessory. It bears N80°48′08″E, 25.24′ from corner point.

A 5/8" iron repar with 1-1/4" red plastic cap marked "43406) bears N17°11'01"W, 68.95' from corner point.

A 5/8" iron rebar with 1-1/4" red plastic cap marked "43406) bears S71°19'36"W, 22.56' from corner point.

No other accessories set by English were tied. His corner form with state plane coordinates and ties to other accessories will be filed at a later date.
