Originally surveyed by Chaplin in 1864. He set a post in a mound of earth, with charred stake and pits.


In 1871 Moody set a post in a mound of earth.

In 1887 Currin and Noland buried charred stake under a mound of earth, dug pits to the East and West, and set a stake in the Eastern pit.

In 1998 Krumbein set a brass cap in Survey 11-85-C. This survey was not filed until after several subsequent surveys were filed, including the corners set in our survey. This creates the distinct probability that there are double corners in the survey affected by 11-85-C.


