A 5/8"x24" iron rebar with 1 1/4" blue plastic cap marked "Wells Surveying 54657PLS" 2" above ground level near a pasture fence corner with fences North and East bears North 46° East, 41.9 feet.

The base at ground level of a stop sign post bears South 35° East, 41.0 feet.

A 3/4" diameter brass washer stamped "PLS 1106" 1.5 feet above ground level in a utility guy pole bears South 46° West, 36.3 feet.
