Record of private survey No. 96 by Kimbrell circa 1898, state he commenced his survey at the ¼ corner between sec. 20 and 21, (Currin and Nolands corner). Record of private survey No. 328 by Kimbrell circa 1910, state he set a post for the ¼ sec. corner.

MONUMENT SET: At the corner point in a farmed field set a 2 3/8" brass cap on 1 1/4"x30" galvanized iron pipe with top 20" below ground level. Monument marked as shown in "Monument Marking Detail".

A silver Deep-1 magnet buried 22" in the ground bears GRID AZIMUTH 26°36', 31.5 feet. A 5/8"x24" iron rebar with 1 ¼" blue plastic cap marked "Wells Surveying PLS 54657" 2" above ground level in field road bank bears GRID AZIMUTH 176°51', 46.9 feet.

A 5/8"x24" iron rebar with 1 ¼" blue plastic cap marked "Wells Surveying PLS 54657" 2" above ground level in fence line bears GRID AZIMUTH $216^{\circ}01$ ', 49.2 feet.

A ¾" diameter brass washer stamped PLS 1106, 0.50' above ground level in railroad tie fence corner post bears GRID AZIMUTH 267°32', 35.8 feet.

Buried bearing object tags with magnets. Wired bearing object tags to rebar. Nailed bearing object tag and witness post sign to railroad tie near brass washer.
