A stone 16x12x4 ins marked and witnessed as described by the Surveyor General except that the marks on the NE and SE witness trees have been obliterated. Likewise the SW witness tree, a dead badly damaged fir has been defaced and a fir 12 ins diam bearing S46°W, 36 lks dist mkd T3N R37E S36 BT
No tree in limit NW.

No record of subsequent monumentation found in Umatilla County survey records.

Description of corner evidence found:

Found a stone 16x12x6 inches with no marks evident in a mound of stone.

Found a 14 inch diameter Douglas Fir snag N20°E, 10.9 feet with scribes visible.

Found no evidence of the other original accessories.

Description of monument and accessories I established to perpetuate the

original location of this corner: In place of found stone, I set a $2\frac{1}{8}$ " x 30" aluminum pipe with aluminum cap marked as shown, 26 inches in the ground, from which:

New Bearing Trees;
A 14 inch diameter Douglas Fir bears N66°E, 43.61 feet marked X BT
A 24 inch diameter Ponderosa Pine bears S69°E, 34.43 feet marked T3N R38E S31 BT
A 12 inch diameter Douglas Fir bears S61°W, 13.84 feet marked T3N R37E S36 BT
A 14 inch diameter Douglas Fir bears N64°W, 28.70 feet marked T3N R37E S25 BT
Buried the unmarked stone South and alongside of monument.
Attached Bearing Tree and Land Survey Monument
signs to the bearing trees.
Raised small mound of stone around monument.
Set a steel fencepost approximately 5 feet
North with Land Survey Monument sign attached.
