Description of corner evidence found:

Found the original stone lying loose on the ground with tracks from a logging tractor over the top of the mound. A steel fence post also was loose along side the mound. A pine stump with the BT scribe plainly visible was N 22°54' W, 26.2' from the mound. A 27" ponderosa pine with a healed blaze lies S 3° E from the mound. A pine stump, cut below the level of the BT scribe on the other original trees found, lies S 78°10' W, 73.5' from the mound

Description of monument and accessories I established to perpetuate the original location of this corner:

The bearings were based on the record bearings of the existing witness

I set a 2 1/2" brass disk on a 30" galvanized Iron Pipe on bedrock 1 foot below the surface of the ground at the record distances from the existing bearing objects. A mound of stone was erected around the monument and the monument marked as in the diagram above. The original stone was buried along side.

I set the following new witness trees:

A 16" dbh Ponderosa Pine bears N46°27'W, 98.9' scribed T3SR31ES23BT.
A 15" dbh Ponderosa Pine bears N43°41'E, 31.7' scribed T3SR31ES24BT.
A 8.6" dbh Ponderosa Pine bears S59°11'W, 25.2' scribed T3SR31ES26BT.
A Brass washer stamped ORLS 852 and WALS 13922 is nailed between the letters B and T on the new trees. All the BT's have BT signs attached. Painted 2, 1" red bands around all the trees and painted the scribe blazes red. Placed a 6' steel post by the mound with a Umatilla County Land Survey Monument sign on it. This work was done October 17, 1995.
