History of original corner establishment:

The original corner was established by George Pershin under G.L.O. contract 430, dated March 23, 1882. His record reads:

Set a basalt Stone 12X10X8 ins 8 ins in the ground, on level. in open glade for 1/4 Sec. Cor, marked 1/4 on N face. no trees near; raised a mound of stone in lieu of pits

Description of corner evidence found:

Found 12x10x8 stone with chisel marks in face. A 1, a / and part of a 4 were visible. The stone was not in a mound. It appeared to have been placed in an old rock jack and to have rolled off down hill when the rock jack rotted out. The proportioned point, under a newer fence, bears N48°20'E, 24.2' from the point where the original stone was found, 6.8' downhill from the old rock jack. There was a long continuous mound of stones under this newer fence. The corner was proportioned in at a point half way between the section corners which were found 1/2 mile east and west of the point. This point fell at the west end of the long stone mound and directly under the fence.

Description of monument and accessories I established to perpetuate the original location of this corner:

Set a 2" I.D. galvanized iron pipe 30" long with 2 1/2" brass cap stamped as shown in the diagram above. Set pipe 4" into the ground on the south sloping face of a large boulder which was just under the ground surface. Buried original stone alongside.

Placed a 4' diameter mound of stone around the monument and set a steel fence post 5' east of the monument with Forest Service Land Survey Monument and Property Boundary signs attached. Scribed 1/4 S11 BT on a 12" Douglas Fir which bears N79°00'E, 97.8'. Scribed 1/4 S14 BT on a 9" Ponderosa Pine which bears \$38°42'E, 128.7'. The bearings are true. Each scribe is in a 24" blaze. Nailed an aluminum washer, stamped RLS 852, between the letters B and T on each tree. Painted a 6" red band around the new bearing trees and attached Forest Service Land Survey Monument and Bearing Tree signs.

I certify the above corner point was perpetuated as hereon described on October 26, 1987.
