


DESCRIPTION OF MONUMENTS AND ACCESSORIES SET AND METHODS USED:

The corner was determined at the intersection of lines connecting opposite corresponding quarter corners. At the corner point, I set a $5/8" \times 24"$ iron pin 14" into a drill hole in bedrock, and attached a $3\frac{1}{4}"$ USFS brass cap. Built a 2.5 ft. diameter mound of stone around the monument to top of cap. Cap is marked as shown below.

From which, I SET NEW REFERENCE POINTS:

- ► A 5/8"x 8" iron pin, driven to bedrock, bears N.44°24'E., 26.71 ft., with attached 2" aluminum cap marked RP 1 2024 PLS 69454
- ► A 5/8"x 8" iron pin, driven to bedrock, bears S.47°16'E., 42.56 ft., with attached 2" aluminum cap marked RP 2 2024 PLS 69454
- ► A 5/8"x 8" iron pin, driven to bedrock, bears S.44°58'W., 38.86 ft., with attached 2" aluminum cap marked *RP 3 2024 PLS 69454*
- ► A 5/8"x 8" iron pin, driven to bedrock, bears N.61°44'W., 41.24 ft., with attached 2" aluminum cap marked *RP 4 2024 PLS 69454*

CORNER MONUMENT MARKED:



Used RTK GPS to measure reference points. Bearings are geodetic, derived by GPS observation at the corner. Set an aluminum guard post north, 13.5 ft. in a north-south running fence line, with USFS 54-2 and 54-9 signs attached, and another west, 7 ft. in an east-west running fence line, with USFS 54-2 sign attached. Corner is located 1.5 ft. south of a wooden fence corner post, with fences running north and west.
