PREVIOUS RENEWALS/SURVEYS ETC.:

Corner was originally established by Dolphus S. Payne, under Contract No. 100, dated August 1, 1861. Notes state: Set charred stake with mound, trench, and pits as per instructions.

MONUMENT AND ACCESSORIES FOUND: None. Corner falls in farmed field about 15 feet west of a North-South fence line. A fence corner with fences East-West and South bears N 16° E, 68'+-.

MONUMENT SET:

The fence corner NE of this corner point has existed for many years. In Survey No. 05-100-C, I accepted several fence corners as best remaining evidence of the original corner points, but those accepted fence corner locations agreed consistently with GLO record dimensions and the fence corner NE of this corner point does not. David Haddock, in his Survey No. 06-263-C did not accept the fence corner NE of this corner point, nor did he accept the old fence corner at the NW Corner of this section. I reestablish this corner point by double proportionate measure as indicated on the accompanying Record of Survey. At the reestablished corner point, I set a 2 3/8 " brass cap on 1 1/4" x 30" galvanized iron pipe with cap 14" below ground level. Monument marked as shown in monument marking detail.

New Accessories:

A 3/4" brass washer stamped "PLS 1106" 1 foot above ground level in wood fence post bears South 71° East, 17.2 feet.

A 3/4" brass washer stamped "PLS 1106" 1 foot above ground level in wood fence post bears South 24° East, 38.8 feet.

A Purple Deep-1 magnet buried 20" below ground level bears South 51° West, 32.7 feet. A Orange Deep-1 magnet buried 20" below ground level bears North 61° West, 30.0 feet.

Attached bearing object signs to wood fence posts by brass washer accessories. Buried bearing object signs with magnets. Set steel fence post with witness sign attached 1 foot East of monument.

LOCATION AND COMMENTS: Corner is located in an actively farmed field.
