A 5/8" x 24" iron rebar with a 1 1/4" purple plastic cap marked "Wells Surveying 54657PLS", on a small bank between the East edge of Mansfield road and the edge of a farmed field bears North 25° East, 24.3 feet.

A 5/8" x 24" iron rebar with a 1 1/4" purple plastic cap marked "Wells Surveying 54657PLS", 5 feet Northwesterly of Pacific Power and Light Pole No. 235901 bears South 08° East, 123.9 feet. A 5/8" x 24" iron rebar with a 1 1/4" purple plastic cap marked "Wells Surveying 54657PLS", on a small bank between the West edge of Mansfield road and the edge of a farmed field bears South 20° West, 41.4 feet.

A 5/8" x 24" iron rebar with a 1 1/4" purple plastic cap marked "Wells Surveying 54657PLS", 0.50' East of a railroad tie marker post bears South 89° West, 27.8 feet.
