Record states: Set post Cor. for Secs. 7, 8, 17 & 18; drove charred stake, dug pits and raised mound as per instructions. Corner remonumented by J. C. Arnold, County Surveyor, on Umatilla County Survey recorded at Book 1, Page 264. Record states: Found the charred end of the original sec. post, I set an alkali stone 15 x 9 x 4 ins., 15 ins. In ground, for sec. cor., mkd. 5 notches on E. edge and 4 notches on S. edge. Corner remonument by Krumbein Engineering Ltd., on Umatilla County Survey No. 83-76-C. Record states: In 1973 Staebler found fence corner and has a signed statement that in the past there had been a marked stone that was dozed out, he set a 2" x 36" iron pipe, K.E.L. found 1 1/2" pipe set by Staebler and replaced pipe with brass cap monument.

A 5/8" x 30" iron rebar with a yellow plastic cap stamped "OR PLS 1106, WA PLS 17372" bears S 13° E, 21.1 feet.

A 5/8" x 30" iron rebar with a yellow plastic cap stamped "OR PLS 1106, WA PLS 17372" bears N 82° W, 25.0 feet.

Set steel fence posts with witness post signs beside all 5/8" iron rebars with bearing object signs wired to rebars.

Buried bearing object sign alongside deep-1 magnet.
