MONUMENT SET:

At a point 89.0 feet North of the centerline of the former location of the Oregon-Washington Railroad and Navigation Company railroad tracks, at a point where field lines extend North and East and West, set a 2 1/2" brass cap on 1 1/2" by 30" galvanized iron pipe, 28" in the ground, marked as shown on "Monument Marking Detail", from which:

A silver "deep-1" magnet, buried 20" in the ground, bears N 29° E, 38.1 feet. A purple "deep-1" magnet, buried 20" in the ground, bears S 41 1/2° E, 33.0 feet. A blue "deep-1" magnet, buried 20" in the ground, bears S 46° W, 36.1 feet. A orange "deep-1" magnet, buried 20" in the ground, bears N 39° W, 40.6 feet.

Buried bearing object signs alongside "deep-1" magnets. The corner monument is located 1 foot West of the West edge of a power transmission line pole.
