Notes state: Set a post 36 x 3 x 3 ins. 12 ins. in the ground for 1/4 Sec. cor. marked 1/4 S. on N. face. Dug pits 18 x 18 x 12 E. & W. of cor. 5 1/2 ft. dist. I raised a mound of of earth 1 1/2 ft. high 3 1/2 ft. base around post. Corner was re-established by John Kimbrell, County Surveyor, in survey reported in Record of Private Surveys Book 2, Page 138, dated 1909. Kimbrell set "a stone" for the corner.

MONUMENT AND ACCESSORIES FOUND: None. This corner position was re-established by single proportionate measurement between the Southwest corner of Section 32 and the Southeast corner of Section 33.
