A.J.Lommasson remonumented the N & S quarter-section corners of Sec. 7 in 1971...No certified record of land corner monumentation was found in County records. However, the Umatilla National

Forest has a land corner card on file for each corner prepared by J.W.Blom in April 1972, and Blom's recovery record states: A basalt stone, scribed 1/4 on one side and a mound of stone and a B.T., 36" pine, bears S38 E. Approx. 200 ft dist. with the face partially chopped out & some scribing visible and legible. (Set) 2" pipe, 36" long with bottom flared and a 3" bronze disk brazed to the top, 24" into the ground. The original basalt stone is set next to the pipe with the original scribed 1/4 visible and legible. New BT is a 28" red fir bearing S40°W, 74 ft dist marked 1/4S7 BT. BT poster on both BT's. Location poster and yellow attention poster on the new BT.

Found a 15x9x5" basalt stone with "1/4" alongside monument, A 3" brass cap on $2\frac{1}{2}$ " galvanized iron pipe protruding 10" from a mound of stone. A 40" ponderosa pine brs S38°E, 207.8' with scribes visible on opened blaze.(OBT) A 28" douglas fir brs S40°W, 70.8' with healed blaze. (Lommasson BT)

Description of monument and accessories I established to perpetuate the original location of this corner:

Maintained monument by mounding more stone around the monument. I etched Township and Range on monument with pocket knife.

New bearing trees established: A 24" douglas fir bears N65°W, 171.1' scribed 1/4S6 BT.

New bearing tree has brass washer stamped PLS 1106 nailed to face of blaze. Set steel fence post West of corner and attached sign 54-4.

Compass declination 190 East.

I hereby certify that the above described corner monument was properly maintained to USFS standards by me on August 12, 1988.

Note: Attached signs 54-3 and 54-4 and painted face of blaze and 6" red band around each bearing tree.
