## History of original corner establishment:

Corner established by Robert F. Omeg, U.S. Deputy Surveyor, under his Contract No. 761, dated June 16, 1905.


Surveyor General records state:

Set a basalt stone 18x12x6 ins. 14 ins. in the ground for 1/4 sec.cor. marked 1/4 on W. face; from which,

A fir 6 ins. diam. bears  $S12^{\circ}E$ , 57 lks dist marked 1/4S8 BT.

A fir 6 ins. diam. bears S85°W, 195 lks dist marked 1/4S7 BT.



## Description of corner evidence found:

Found an upright 18x12x6" basalt stone with fractured west face on a mound of stone from which:

A 12" douglas fir brs  $\rm S86^OW$ , 87.1' with scribes visible on opened blaze.(OBT) A 12" douglas fir brs  $\rm S22^OE$ , 37.6' with scribes visible on opened blaze. (OBT)

NOTE: Mound of rocks and corner stone were painted with yellow paint.

## Description of monument and accessories I established to perpetuate the original location of this corner:

At position of found stone...

Set  $2\frac{1}{2}$ " aluminum cap on  $2\frac{1}{2}$ " x 30" aluminum pipe 22" in ground to bedrock & surrounded with mound of earth & stone. Set 6' fence post North of corner with sign 54-4 attached. Cap marked as shown in corner diagram. Buried corner stone in new mound.

New bearing trees established: A 13" ponderosa pine brs  $S6^{\circ}W$ , 2.0' scribed 1/4S7 BT. A 6" douglas fir brs  $N82^{\circ}E$ , 32.9' scribed 1/4S8 BT.

New bearing trees have a brass washer stamped PLS 1106 nailed to face of blaze. Attached sign 54-3~&~54-4 to each BT and painted face of blaze &~6" red band around each BT.

Compass declination 190 East.
