A 5/8" rebar with 2" Al cap bears N67°10'W, 48.5', stamped BO Cor S67°10'E 48.5'. A 5/8" rebar with 2" Al cap bears S30°32'W, 47.7', stamped BO Cor N30°32'E 47.7'. Rebar is exposed 8". A 5/8" rebar with 2" Al cap bears S73°24'E, 48.4', stamped BO Cor N73°24'W 48.4'. Rebar is exposed 8". The bearings are based on traverse control stations and are true. A brass washer stamped ORLS852 and WALS 13922 is attached between the letters B and T with a brass screw on each new tree. All the BT's have Bearing Tree and Land Survey Monument signs attached. A red stripe is painted around each tree at chest height.
