Description of corner evidence found: Found the iron pipe as described with brass cap stamped as shown in the diagram. From this monument: A 16" dbh dead and down Spruce, N30°W, 20' with visible BT scribe. Description of monument and accessories I established to perpetuate the original location of this corner: The bearings were based on the surveyed bearing between this 1/4 section corner and the corner to the west as recorded by RPE 2808 in a filed Umatilla County survey. I set the following new witness trees: A 25" dbh Engleman Spruce bears N57°15'W, 22.5' scribed 1/4 S32 BT; A 17" dbh Engleman Spruce bears S75°23'W, 44.5' scribed 1/4 S5 BT. A 14" dbh Engleman Spruce bears N81°47'E, 37.5' scribed 1/4 S32 BT. A 21" dbh Engleman Spruce bears S78°50'E, 19.3' scribed 1/4 S5 BT. An aluminum washer stamped RLS 852 is nailed between the letters B and T on each new tree. All four living trees have LSM and BT signs attached.
