In 1939, the GLO remonumented this corner. Their record reads:

Set an iron post, 3 ft. long, 2 ins. diam., 27 ins. in the ground, with brass cap marked (diagram)

from which

A pine, 20 ins. diam., brs. N.50 1/2°E., 15 lks. dist., marked T4NR38ES33BT. A Tamarack, 12 ins. diam., brs. N.61°W., 30 lks. dist., marked T4NR38ES32BT.

In 1982, PLS 933 added a bearing tree to this corner as described. A 18" Tamarack N16°E 29.3 ft. mkd T4N, R38E, S33 BT.

Description of corner evidence found:

Found the iron pipe as described with brass cap stamped as shown in the diagram. From this monument:

A 14" dbh Tamarack, N60°49'W, 19.1.' with healed blaze.

A 18" dbh Tamarack, N16°59'E, 29.8', with open scribe blaze.

Description of monument and accessories I established to perpetuate the original location of this corner:

The bearings were based on the surveyed bearing between the 1/4 section corner and the southwest corner of section 32 as recorded by RPE 2808 in a filed Umatilla County survey. I set the following new witness trees: A 12" dbh Engleman Spruce bears S14°53'E, 13.4' scribed T4N R38E S35 BT; A 18" dbh Tamarack bears S11°47'W, 6.0' scribed T4N R38E S35 BT. An aluminum washer stamped RLS 852 is nailed between the letters B and T on each new tree. All four living trees have LSM and BT signs attached. Painted 6" red bands around all four living trees and painted the scribe blazes red.
