TOWNSHIP REMONUMENATION SURVEYS WERE COMPLETED IN THIS AREA IN SURVEYS 88-045-C AND 98-101-C. I HELD CORNERS SHOWN ON THESE SURVEYS FOR SUBDIVISION OF SECTION 15. SPECIFIC REFERENCES OF THE C-W 1/16 CORNER ARE AS FOLLOWS: IN OCTOBER OF 1950 SURVEYS Q-764-A, Q-1271-A AND Q-1570-AX BY V.R. FRALEY SHOW A 1/2" IRON ROD AT THE CALCULATED CORNER LOCATION. AN UNDATED SURVEY Q-0766-A BY V.R. FRALEY SHOWS A 1/2" IRON ROD AT THE CORNER (FRALEY'S POINT) WITH AN ADDITIONAL POSITION CALLED "STORM'S POINT" CALLED AS BEING 12.4' SOUTH OF THE IRON ROD. SURVEY 94-038-B BY DENNIS EDWARDS IN JANUARY OF 1994 CALCULATED THE POSITION AND SET A REBAR 30 FEET EAST ON THE PURPORTED ROAD EASEMENT RIGHT-OF-WAY. PARTITION PLAT 1995-34 BY RONALD MCKINNIS CALCULATED THE POSITION. IN PARTITION PLAT 2001-32 DATED MAY OF 2001, ROBERT STRATTON SET A 5/8" X 30" REBAR WITH 2" ALUMINUM CAP AT THE CALCULATED LOCATION. SURVEY 15-104-B BY DAVID BAALMAN FOUND AND ACCEPTED THE 2" ALUMINUM CAP SET BY STRATTON IN 2001.

FOUND 5/8" X 30" IRON REBAR WITH 2" ALUMINUM CAP DESTROYED BY RECENT UTILITY INSTALLATION.
