
We have rejected the position of the 1/4 corner established by C.S. 88-045-C, due to that survey's rejection of a 1/2" rebar in a stone mound at N-25, shown as found on that survey as well as on C.S. Q-0775-A and County Surveyor's record Utility Slide No. 83. We found & accepted the 1/2" iron rebar in stone mound at N-25, and computed a new position for L-25 by single-proportion between N-25 and the USACOE brass cap found at J-25.

Found 5/8" iron rebar with plastic cap marked "LS 48509" S04°12'15"W 278.31 feet from the revised corner; replaced existing bearing tag on adjacent T-post to reference the revised corner;

Found 5/8" iron rebar with plastic cap marked "LS 951" S21°29'16"W 388.58 feet from the revised corner; wired bearing tag to the rebar to reference the revised corner;

Found 5/8" iron rebar with bearing tag attached by wire, N36°30'57"E 251.22 feet from the revised corner; replaced existing tag with a new tag to reference the revised corner.
