Cor. post; made mound and drove charred stake, as per instructions. Re-established by G. Dennis Edwards, Umatilla County Survey Record #91-01-B, dated January 1991. Record states: No evidence found. Set by single proportion set a 2 3/8" Brass Cap attached to the top of a 1"x30" Galv. pipe. Cap is 0.4 ft. above surface of ground and in a row of grapes, stamped as shown in "Monument Marking Detail". Accessories: Set 4 - 1/2" x 24" I. Rebar with Alum. Caps stamped 951. Set a steel fence post behind each of these 1/2" rebars with Bearing Object signs attached. They bear N 30°36' W 757.36 feet, West 406.84 feet, South and East 230.37 ft. from corner.

Found a 2 3/8" brass cap on 1" iron pipe, 2" above ground in a grape row. Monuments found:

A 1 1/2" aluminum cap bears S89°56'E, 230.5' stamped "WC 230.37' East, LS 951".

A 1 1/2" aluminum cap bears South, 10.00' stamped "WC 10.00' South, LS 951"

A 1 1/2" aluminum cap bears S89<sup>0</sup>57"W, 406.6' stamped "WC 757.36', N30<sup>0</sup>36'W, LS 951".

A 1 1/2" aluminum cap bears N30<sup>o</sup>36'W, 757.0' stamped "WC 406.84', LS 951". Aluminum caps are on 1/2" iron pins.
