PREVIOUS RENEWALS/SURVEYS ETC.:

Corner originally established by Odell & Lewis, under GLO Contract No. 110, dated February 7, 1865. Notes state: Set post Cor. for Secs. 7, 8, 17, 16. Drove charred stake; dug pits & raised mound, as per instructions.

The corner was declared lost and was re-established by J.W. Kimbrell in Record of Private Surveys, Survey No. 125. Kimbrell's notes state: "set stone 22 x 10 x 6 for cor. secs 17 & 18 19 & 20".

MONUMENT AND ACCESSORIES FOUND:

None. Corner area falls in a "rock field" in a North-South fence line. Many of the stones in the corner area have been placed in rock cribs or wire barrels to support the fence. There is no evidence of fences or field lines extending into the corner area from the East or West.

MONUMENT SET:

I re-established this corner position perpendicular to the midpoint of a line between the West 1/4 corners of Sections 8 and 17, holding the existing North-South fence line for departure. At re-established corner position, set a 5/8" x 16" rebar driven to bedrock, with 2" aluminum cap. The aluminum cap is 4" above ground level. Cap marked as shown in Monument Marking Detail. New accessories:

A 5/8" x 24" rebar with a 1 1/4" yellow plastic cap marked "OR PLS 1106 WA PLS 17372", with cap 1" above ground level bears North 01° East, 27.1 feet.

"XBO" chiseled in the top of a 24"x24"x18" (exposed area) immovable rock bears North 47° East, 30.2 feet. Measured to "X".

A 5/8" x 24" rebar with a 1 1/4" yellow plastic cap marked "OR PLS 1106 WA PLS 17372", with cap 1" above ground level bears South 45° East, 22.0 feet.

"X" chiseled in East face of a rock out crop, 6" above the ground line bears North 45° West, 1.6 feet.

Attached bearing object signs to rebar accessories. Nailed "witness" sign to wood fence post 6 1/2' North of corner monument.
