### PREVIOUS RENEWALS/SURVEYS ETC .:

Corner originally established by Odell & Lewis, under GLO Contract No. 110, dated February 7, 1865. Notes state: Set 1/4 Sec. post; drove charred stake; dug pits & raised mound, as per instructions.

In Record of Private Surveys, Survey No. 106, the corner was not found and was re-established by Survey. A 20 x 20 x 5 inch stone, marked "1/4" was set for the re-established corner. Survey No. 182, recovered this stone.

## MONUMENT AND ACCESSORIES FOUND:

Railroad tie fence corner with fence and field berms running East, West, and South, and a field berm running North.

### MONUMENT SET:

I accepted a railroad tie fence corner with fence and field lines running East, West and South and a field berm running North as best remaining evidence of original corner location. At the north side of the railroad tie fence corner, set a 2 1/2" brass cap on 2 1/2" x 30" galvanized iron pipe, 30" in the ground with cap marked as shown in Monument Marking Detail.

New accessories:

A 5/8" x 24" rebar with yellow plastic cap marked "OR PLS 1106, WA PLS 17372" bears South 86° East, 55.2 feet.

A 5/8" x 24" rebar with yellow plastic cap marked "OR PLS 1106, WA PLS 17372" bears South 86° East, 28.8 feet.

A 5/8" x 24" rebar with yellow plastic cap marked "OR PLS 1106, WA PLS 17372" bears South 03° West, 38.4 feet.

A 5/8" x 24" rebar with yellow plastic cap marked "OR PLS 1106, WA PLS 17372" bears North 87° West, 37.2 feet.

Wired bearing object signs to the rebar accessories. Nailed "witness" sign to the railroad tie post near the corner.

LOCATION AND COMMENTS: Survey No. 106 calls for a 20" x 20" x 5" stone. We probed and dug around railroad tie fence corner without finding a stone this size. There are several piled stones around the railroad tie post.
