Corner was originally established by Odell & Lewis, under GLO Contract No. 110, dated February 7, 1865. Notes state: Set post Cor. for Secs. 21, 22, 27 & 28; drove charred stake; dug pits & raised mound, as per instructions.

In Record of Private Surveys, Survey No. 106, calls for the "corner to Secs 21-22-27 & 28". Survey No. 182, diagram, uses the same record dimensions as Survey No. 106. Both of these surveys were made by J.W. Kimbrell. Survey No. 182 subdivided Section 28.

MONUMENT AND ACCESSORIES FOUND: 2" diameter iron fence corner post, in a fence running East & West.

MONUMENT SET:

I accepted the 2" diameter fence corner post, in East & West fence as best remaining evidence of the original corner location. There is also a field berm extending South from this point. At the corner point, just North of 2" fence corner post, set 2 1/2" brass cap on a 2 1/2" x 30" galvanized iron pipe, 24" in the ground, marked as shown in Monument Marking Detail.

A 5/8" x 30" rebar with a yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", with top 1" above ground level in fence line bears East, 21.3 feet.

A 5/8" x 30" rebar with a yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", with top 1" above ground level in fence line bears East, 41.0 feet.

A 5/8" x 30" rebar with a yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", with top 1" above ground level in fence line bears West, 26.8 feet.

A 5/8" x 30" rebar with a yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", with top 1" above ground level in fence line bears West 48.6 feet.

Attached bearing object signs to all rebar accessories. Attached "witness" sign to 2" diameter fence post 0.5 feet South of brass cap monument.
