## PREVIOUS RENEWALS/SURVEYS ETC.:

Corner originally established by Odell & Lewis, under GLO Contract No. 110, dated February 7, 1865. Notes state: Set Standard Cor. for 1/4 Sec. on level; drove charred stake, dug pits and raised mound as per instructions.

In Record of Private Surveys, a unnumbered Survey in Book 1, pages 133 & 134, in 1885, Peter Zahner recovers unmistakable evidence of the corner and renews it by planting a rock 3 x 10 x 15" with a plate underneath it.

#### MONUMENT SET:

I held the centerline of East-West Watts Road with the projected intersection of a fence corner and field berm extending North as the best remaining evidence of the original corner location. See Survey No. 02-021-C for additional information. At re-established corner position, set a 2 1/2" brass cap on a 1 1/4 by 30" galvanized iron pipe with cap 12" below gravel road surface, marked as shown in Monument Marking Detail.

#### New accessories:

A 3/4" brass washer stamped "PLS 1106" located 1.0 foot above ground level in PP&L power pole #335003, bears North 07° West, 26.6 feet.

A 5/8" x 24" rebar with 1 1/4" yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", cap flush with ground bears South 80° East, 70.2 feet.

A  $5/8" \times 24"$  rebar with 1 1/4" yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", cap flush with ground bears South 79° West, 52.4 feet.

A 3/4" brass washer stamped "OR PLS 1106", located 1.0 foot above ground level in PP&L guy pole #335001 bears North 53° West, 47.9 feet.

Attached bearing object signs to all accessories. Attached "witness" sign to PP&L pole #335003.

LOCATION AND COMMENTS: Corner is located in centerline of Watts Road. A field line extends North.
