

Previous Renewals / Surveys, etc.

Corner originally set by Odell and Lewis under contract No. 110 dated February 7, 1865. Their record reads: Set 1/4 Sec. post, drove charred stake, dug pits and raised mound, as per instructions. John Kimbrell, in the record of private surveys Book 1, Page 393, reports finding the point of the charred stake which he left in place. He placed particles of the stake in a colored glass bottle and burried with one quart of stone coal 1 foot south of the original stake. Over the bottle and coal he set a stone 21x10x7 marked 1/4on the south face and "X" on top.

Monument and Accessories found: (condition and source) The intersection of field lines to the east, west, and south.



MONUMENT (S) AND ACCESSORIES SET (Procedures and Description) At the intersection described above, I set a 2 3/8" brass cap on a 1 1/2" x 30" galvanized iron pipe stamped as shown in the diagram above 24" below the surface of the farmed field.

For references, I set four 5/8" by 24" iron rebars with 1 1/4" orange plastic caps stamped WTS and 56295LS as described below 20"below the surface: an iron rebar bears S88°37'20"W, 25.03 feet: an iron rebar bears N3°07'49"E, 23.17 feet; an iron rebar bears S84°14'35"E, 24.98 feet; an iron rebar bears S5°00'01"W, 25.99 feet;

The monument and references were tied using a Trimble R7/R8 RTK GPS system.
