PREVIOUS RENEWALS/SURVEYS ETC.: Corner originally established by George S. Pershin, under Contract No. 373, dated September 17, 1880. Notes state: Set pine post on level for cor. to Sec. 1, 2, 11 & 12. A pine, 20 ins. diam. brs. N 17° E., 53 lks. Dist., a pine, 22 ins. diam. brs. S 75° E., 49 lks. dist., a pine, 15" diam. brs. S 60° W., 63 lks. dist., a pine, 10 ins. diam.brs. N 63°W., 67 lks. dist.

MONUMENT AND ACCESSORIES FOUND: Found root hole of SW BT with uprooted stub of tree lying nearby, bears S 60° W., 44.2 feet. No trace of other bearing trees. The corner area has been logged and cleared for a gate and fence building. There are indications of an old road bed extending South from the corner area. Corner falls at a turn in County Road No. 1447 and fits the County Road extending West and North, in conformance with original County Road survey notes, (road notes state the survey of the portion of County Road No. 1447 extending West began 20 feet South of the corner and that position lines up with the road centerline extending West). There was a USFS bearing tree tag on a 32" ponderosa pine bearing N 65° W., 67.3 feet from corner. We cut into the tree and find no evidence of a blaze face. The tree has a fence build through it and there is evidence of scarring from fence construction.

MONUMENT SET:

At a point N 60° E., 44.2' from SW bearing tree remains, set a 2 1/2" brass cap on a 1 1/4" x 30" galvanized iron pipe with cap 3" above ground level in a small mound of stone. Monument cap marked as shown in "Monument Marking Detail".

New Accessories:

A 3/4" Brass washer stamped "PLS 1106" 1 foot above ground level nailed to a rail road tie gate post bears N 73° E, 39.8 feet.

A 26" diam. ponderosa pine scribed "T5S R31E S12 BT" with a 3/4" brass washer stamped "PLS 1106" nailed to the blaze bears S 44° E, 109.0 feet.

A 10" diam. ponderosa pine scribed "T5S R31E S11 BT" with a 3/4" brass washer stamped "PLS 1106" nailed to the blaze bears S 50° W, 148.2 feet.

A 32" diam. ponderosa pine bears N 65° W, 67.3 feet. This tree was opened with a chain saw in searching for the corner and has a 6" by 5" by 16" wedge cut from it.

Attached bearing object signs to accessories. Attached witness sign to rail road tie gate post, North of the corner.

LOCATION AND COMMENTS:

Corner falls at projection of the center of County Road No. 1447 extending North and the North edge of County Road No. 1447 extending West. Corner located 4 feet South of fence on South side of road.
