MONUMENT SET:

Reestablished corner by double proportion measurement between the recovered NE Corner of Section 14, the recovered East 1/4 Corner of Section 23, the recovered South 1/4 Corner of Section 14 and the recovered South 1/4 Corner of Section 13. At position determined by survey, set a 2 1/2" brass cap on a 1 1/4" x 30" galvanized iron pipe with top of cap flush with ground in a large marshy meadow. Monument marked as shown in "Monument Marking Detail". The corner accessories are all west of the monument where a fence and field road exist. New Accessories:

A 5/8" x 24" iron rebar with a yellow plastic cap marked "OR PLS 1106, WA PLS 17372", 2" above ground in a wire fence running along a field road bears S 45 1/2° W, 133.4 feet. The top center of the east side of a 24" diameter CMP culvert under a field road bears S 84° W, 118.9 feet.

A 3/4" brass washer stamped "PLS 1106" nailed to a wood fence post rock crib 1 foot above ground bears N 64° W, 108.1 feet.

A 5/8" x 24" iron rebar with a yellow plastic cap marked "OR PLS 1106, WA PLS 17372", 2" above ground in a wire fence running along a field road bears N 41° W, 162.0 feet. Attached bearing object signs to all accessories other than the culvert. Set a steel fence post with a witness post sign wired to it 1 foot North of the corner.

LOCATION AND COMMENTS: Corner is located in a wet marshy meadow approximately 100 feet East of a N-S farm road.
