MONUMENT AND ACCESSORIES FOUND:

Found both original bearing trees. Bearing tree N 14°E, 118 links is cut approximately 15" above ground level with no visible scribing, diameter approximately 32". Bearing tree at S 50° W, 129 links is cut approximately 30" above ground level with scribing "BT" visible, scribing measures 20" out from centerline of stump (40" diameter stump). Found the original stone marked "1/4" in a rock jack 8' South of corner position.

MONUMENT SET:

Reestablished corner position by distance-distance from original bearing trees, measureing from face of blaze. At reestablished corner position, set a 2 1/2" brass cap on a 1 1/2" x 30" galvanized iron pipe with cap 4" above ground level in a North-South fence, marked as shown in "Monument Marking Detail". Buried original stone on West side of brass cap monument and raised a small mound of stone and earth around monument.

A 23" ponderosa pine scribed "1/4 S24 BT", bears N 52 1/2° E, 98.2 feet.

A 18" ponderosa pine scribed "1/4 S24 BT", bears S 70 1/2° E, 82.1 feet.

A 16" ponderosa pine scribed "1/4 S23 BT", bears S 70° W, 75.7 feet.

A 12" ponderosa pine scribed "1/4 S23 BT", bears N 43° W, 65.4 feet.

Attached bearing object signs to new bearing trees and to both original bearing tree stumps.
