MONUMENT SET: Reestablished corner position by extending bearing and distance measured between recovered corners at the Center 1/4 and Center South 1/16th Corners of Section 21, Southerly from the Center South 1/16th Corner of Section 21. At position determined by survey, set a 2 1/2" aluminum cap on a 2 1/2" x 30" aluminum pipe with top 18" below ground. Placed original corner stone on West side of new monument.
