
Previous Renewals/Surveys, etc.: Originally surveyed by U.S. Deputy Surveyor William Odell under his contract No. 110, dated 8-23-1865. The Surveyor Generals notes state, "set quarter section corner post, drove charred stake, dug pits and raised mounds as per instructions." Survey No. 210, Book 1, Page 572, dated December 3, 1904, Kimbrell found a stone. Survey Q-835-C, dated 10-15-1962, Harris set a 1 1/2" iron pipe 6" under the road at surveyed position. Survey N-21-C, dated July 1977, Swan set a railroad spike at the surveyed position. Circa 1995 The Oregon Department of Transportation resurfaced the roadway and replaced the railroad spike with a brass cap in case.


