Previous Renewals/Surveys, etc.: Originally surveyed by U.S. Deputy Surveyor William Odell under his contract No. 110, dated 8-23-1865. The Surveyor Generals notes state, "set quarter section post corner, drove charred stake, dug pits, and raised mounds as per instructions." Survey No. 173, Book 1, Page 516, dated September 22, 1903, Kimbrell mentions this corner but does not describe it. County Survey No. 427, Book 2, Page 303, dated April 1919, Perry used this corner to subdivide the Northwest quarter of section 35, but does not describe it. Survey No. 02-18-B, dated 02-2002, Haddock set a 2 1/2" brass cap on a 1"x30" galvanized iron pipe based on the found Perry rock at the Northwest corner of section 35 and Perry's found Northwest 1/16 corner of section 35.


# Monument(s) & Accessories Found (Condition & Source):

A 5/8 rebar with yellow plastic cap stamped 'Tomkins Surveying' which bears N 50°E ~ 18.52 from the corner in the pavement. Attached a Umatilla County Bearing object sign to t-post. A 5/8 rebar with yellow plastic cap stamped 'Tomkins Surveying' which bears S 33°E ~ 27.81 feet from the corner. No Umatilla County Bearing object sign or t-post set. A 5/8 rebar with yellow plastic cap stamped 'Tomkins Surveying' which bears S 50°W ~ 47.07 feet from the corner. Attached a Umatilla County Bearing object sign to the northeast face of power pole. A 5/8 rebar with yellow plastic cap stamped 'Tomkins Surveying' which bears N 33°W ~ 32.37 feet from the corner. Attached a Umatilla County Bearing object sign to the southeast face of power pole.
