John Kimbrell, in his survey recorded at Book 1, Page 402, Record of Private Surveys, reestablished the corner and set a stone, 20 x 10 x 8.

Steve Haddock, under Survey No. 08-039-C, calculated a position for this corner at the intersection of the centerline of Whiteman Road with the field berm extending South.

MONUMENT AND ACCESSORIES FOUND: None. There is a old established field line and berm, extending South, from the corner point. Field line and berm show on the 1956 ASCS aerial photography.

MONUMENT SET: I reestablished this corner point at the intersection of the centerline of Whiteman Road with an old field berm extending South, (see Survey No. 08-039-C). At the reestablished corner point, set 2 3/8" brass cap on a 1 1/4" x 30" galvanized iron pipe with cap 9" below road level, marked as shown in "Monument Marking Detail".
