A 22 inch diameter fir with a healed blaze and bearing tree tag bears S81¼°E 19.8 Feet. An 18 inch diameter fir with a healed blaze and bearing tree tag bears S69°W 28.4 Feet.

No evidence of the other two 1965 bearing trees remain.

Found a 3½ BLM brass cap on a 2½ inch iron pipe marked T6N, R37E S23, S24, S25, S26 1965, from which the remains of the original bearing tree: a 36 inch diameter fir snag with rotted blaze bears S26°E 7.3 feet.
